15.216. Representations from Interested Parties

The Police gave a brief crime report and advised they have been monitoring HGV's going through the town with weight limit restrictions. The Police are struggling as when planning was approved for the new building sites from ENC, the planners did not restrict HGV's going through the town. Question from the public as to who will enforce this to ensure safety of residents? Police cannot prosecute any lorry coming into Oundle at the moment. We can only do this on new planning applications.

15.217. Consideration of Requests from Interested Parties

Public Participation section for a minimum of 15 minutes in every Full Council Meeting;

County Councillor Heather Smith spoke about the application for town green status of the land on Glapthorn Road and explained why she put in an objection against this application. Cllr Smith advised in order to raise the 22 million pounds needed for school improvements it was always clear that this field would be sold to raise some of this amount, and that it was a miscomprehension that when PWS becomes an academy that other sources of funding will be available.

PROPOSITION "That the Council make a commitment to support the Town's Youth Cafe for the next five years"

Former councillor Debbie Murphy requested that a councillor take on the proposal to support the youth café for the next five years? It was agreed to consider this request.

PROPOSITION "That the remaining members of Oundle Town Council stand down to allow an election to take place, as only Cllrs Chesser, Chapple and N. Oakes are there through election the others have been co-opted."

Former councillor Debbie Murphy handed in a petition to ask for the above proposition to be considered. The petition will be considered. Cllr Phil Stearn explained that the district council would take over the running of the Town Council if the current council was disbanded.

Leigh Giurlando from the Oundle Chronicle gave an overview of the elections history of Oundle Town Council since the last election in 2007. After the 2015 election 3 councillors were co-opted on as there were not enough candidates to stand.

Neil Fraser former councillor addressed everyone present, previously people have not cared enough to stand up and offer themselves as councillors. The Council represent the town and it is important that people stand. Mr Fraser also gave an overview of the Neighbourhood Plan and advised that in light of current events the development does need to continue. He would like to propose that the development of the plan is taken back into the community, who will then deliver the draft plan to the Town Council which will then go to referendum.
