Questions to Danny Moody, Chief Executive of NCALC, on the issue of Level 3/Level 4 status

PROPOSITION: 'That all written material provided by the Town Council to those persons originally asked to advise the Council on the issue as to whether it is a Level 3 or a Level 4 Council be copied to each Oundle Town Councillor together with their previous written advice to the Council and that those persons who have previously advised the Council on this issue be asked to attend a meeting so that they can answer any questions put to them by Councillors and thereafter provide further oral advice to the Council on the issue of Oundle Town Council's Level 3 status'.

Cllr King gave an overview of the paper submitted in December and the subsequent meetings. He suspended the meeting and introduced Danny Moody from NCALC to answer any questions from Council.

15.196. Consideration of Requests from Interested Parties

Danny Moody initially gave some background to his attendance. He had been asked on 8th December 2015 to assess what profile level Oundle Town Council should be and had produced a report indicating that based on the information given to him he had assessed Oundle as a Level 4 council.

The final paragraph of his report said "I have known Oundle Town Council for nine years and during that time it has been forward thinking and progressive. My perception is that Oundle Town Council is aspirational and forward thinking. I assessed that Oundle Town Council was a Level 4 Council based on the information I was given."

Prior to the meeting Cllr Chapple had submitted a number of questions to Mr Moody and Cllr Chapple followed these up with oral questions on the following issues:

Oundle being categorised as a large town
Oundle Town Council's expenditure budget
Oundle Town Council Staffing
Oundle Town Council's meeting structure

Cllr King then proposed that Oundle Town Council should reaffirm its status as a level 4 council.

Cllr King closed the meeting to vote on the proposition.

Cllr Chapple indicated that he had abstained as the agenda had not provided for there to be a vote on this issue and he had not had time to fully consider the matter in light of Mr Moody's answers.

Crime figures given out:

5 burglaries, 3 criminal damages, 3 motor vehicle thefts, 1 theft from a dwelling. A shop lifting operation has one person in custody.

An update was requested on the status of the missing person, this is still investigated.

Cllr S. Oakes. Raised the question about speeding? This is one of the Police priorities.

15.197.03. District Councillors Report

Cllr Reichhold gave apologies from Cllrs Stern and Vowles and also gave a financial update. The Secretary of State has given a rural services grant to ENC. In future, Councils will be allowed to keep more of the business rates.

Cllr Grove asked about the January Policy Meeting and Oundle's representation on both the Cotterstock Road Field and Fletton Field.

She asked Cllr Reichhold "Do you feel confident about the green space in the town?"

Cllr Reichhold advised that he did. It was noted that Cllr Heather Smith has put in an objection to the Councils application for village green status on Fletton Field.

Cllr Grove advised that "East Northants Council's response of 389 words was not sufficient. Without those fields we lose 60% of the available green space in Oundle."

15.206. Council Matters

- 15.206.01 *PROPOSITION 'That the Council recognizes its current dysfunctional state and all Councillors resign in order to trigger an election.'*

Cllr Grove advised the details of her paper. Only 3 of the 14 Councillors have been elected since 2007. The council is broken. Councillors have accused other councillors of dishonesty without offering explanation or reason as a foundation. We have a Council lacking in trust and respect. We cannot continue this way. We have lost the respect of our staff, the town and each other. Let's give the council a fighting chance to redeem itself.

Cllr King went around the table to each councillor so they could express a view.

Cllr Murphy agrees with the proposition.

Cllr Talbot fully supports the proposition.

Cllr Stagg will be resigning

Cllr Fitzgerald has already resigned with effect from the end of February and has put in a monitoring officer complaint to East Northants Council.

Cllr Chesser has nothing to say.

Cllr Sparkes requested a governance review at the last meeting.

Cllr S. Oakes said it is very sad.

Cllr N. Oakes - I have tried to serve the town, I had expected a certain person to contact me in December and they did not make any contact at the time.

Cllr Chapple - I circulated an open letter to all councillors with my reasons. I accept on the night I went along with it and had concerns afterwards. At no point was any member of staff in danger of losing their position and current

staff would not be affected. We have a process to re-visit a decision within 6 months. I am grateful to Danny for coming along we wanted to make sure we got it right. At the moment we are dysfunctional. We have managed to set a budget and we have been put things in place to allow the staff to function. There is nothing wrong with clearing the decks and starting again.

Cllr Grove - The Clerk sent you a letter and you choose not to respond. It has gone beyond the level 3 or level 4 question.

Danny Moody clarified the legal decision, if this motion is approved then each individual councillor can decide to resign.
